AUGUST 10 - DAY OF SOLIDARITY WITH ARGENTINA

WE ASK FOR INTERNATIONAL SOLIDARITY IN THE FORM OF PROTEST DEMONSTRATIONS IN FRONT OF THE ARGENTINA EMBASSIES, ASKING FOR:

- 1- THE ABOLITION OF LAW 14467 (Act. 333/53), Art. 5to, Inc. 1ro. KNOWN AS "LAW FOR SEARCH OF RECORDS"
- 2- THE ABOLITION OF POLICE EDICTS ESPECIALLY THE FEDERAL EDICT CONCERNING "SCANDAL", Art. 2do, Inc. H. WICH ENABLES THE POLICE TO ARREST FOR SUSPICION OF "INCITATION TO THE CARNAL ACT IN PUBLIC"
- 3- THE STOP OF POLICE RAIDS AND ARRESTS AIMED AT PUNISHING SEXUALITY.
- 4- THE FULL RESPECT OF HUMAN, SEXUAL, GAY AND LESBIAN RIGHTS BY FEDERAL AND PROVINCE POLICE FORCES.
- 5- THE GRANTING OF LEGAL CAPACITY TO C.H.A. (ARGENTINE HOMOSEXUAL COMMUNITY)
- 6- THE ABOLITION OF THE ELECTORAL LAW OF BUENOS AIRES PROVINCE WICH FORBIDS HOMOSEXUAL CITIZENS TO VOTE, ON THE GROUNDS OF THEIR "UNWORTHINESS"

WE WISH THAT PROTEST ACTION CONFIRMED BY A STATEMENT FROM YOUR ASSOCIATION GIVEN TO THE AMBASSADOR OR CONSUL, AND ALSO THAT A COPY BE SENT OF THIS STATEMENT TO C.H.A. CATAMARCA 469-P.B.
